Avoid working in groups, where possible do not work in groups bigger than 2 always maintaining social distance of 2m at all times. Wherever possible plan works to ensure that, a social distance of 2m is maintained.</p> <p><b>Where a 2m distance cannot be maintained, keep at least 1m away from anyone with appropriate added mitigation controls in place, which include,</b></p> <ul style="list-style-type: none"> <li>You should work side-by-side, or facing away from each other, rather than face to face if possible.</li> <li>This <b>MUST</b> only take place for a maximum of 15 minutes.</li> <li>Ensure regular hand washing &amp; surface cleaning takes place and Wear face covering</li> </ul> <p>Ensure you follow basic hygiene procedures by washing your hands frequently using soap and water for 20 seconds, and especially after blowing your nose, sneezing or coughing, on arrival at work, before and after eating, after using public transport and when you arrive home. Where facilities to wash hands are not available alcohol, based hand sanitiser should be used.</p> <p>Regular business briefs produced reminding you all to wash hands on a regular basis using soap &amp; running water Wear your gloves at all times when working to reduce cross contamination of tools &amp; equipment but remember to wash hands thoroughly when gloves are removed. Avoid touching your face, nose, mouth &amp; eyes with hands / gloves. <b>YOU</b> must Stay at home &amp; immediately organize a Covid test if you have either:</p> <ul style="list-style-type: none"> <li>A high temperature – this means you feel hot to touch on your chest or back</li> <li>A new, continuous cough – this means coughing a lot for more than an hour, or 3 or more coughing episodes in 24 hours (if you usually have a cough, it may be worse than usual)</li> <li>A loss or change to your sense of smell or taste – this means you’ve noticed you cannot smell or taste anything, or things smell or taste different to normal</li> </ul> <p>You must also implement the governments track &amp; trace procedures</p> <ul style="list-style-type: none"> <li>order a test immediately at <a href="http://www.nhs.uk/coronavirus">www.nhs.uk/coronavirus</a> or call 119 if you have no internet access</li> <li>If your test is positive, you must complete the remainder of your 10-day self-isolation. Anyone in your household must also complete self-isolation for <b>10 days</b> from when you started having symptoms. If your test is negative, you and other household members no longer need to self-isolate</li> <li>if you test positive for coronavirus, the NHS test and trace service will send you a text or email alert or call you with instructions of how to share details of people with whom you have had close, recent contact and places you have visited. It is important that you respond as soon as possible so that we can give appropriate advice to those who need it. All Work Locations	Employee showing Symptoms at work	Operative All in vicinity	5	3	15	<p>Employees <b>MUST</b> report immediately any symptoms they notice when in the workplace.</p> <p>Where an individual at work reports that they are showing any of the symptoms of Covid-19, the following procedure will take place.</p> <ul style="list-style-type: none"> <li>• <b>Isolate the individual:</b> the individual showing the symptoms <b>MUST</b> be sent home immediately. If the individual is not a car driver they must be isolated from others in the workplace until they can be picked up.</li> <li>• <b>Provide a mask/face covering:</b> provide the individual with a face mask or face covering. If they have their own, ask them to put on their mask or face covering.</li> <li>• <b>Welfare facilities:</b> do not allow the individual to use welfare facilities such as kitchen facilities. If the use of a toilet is required, try to use facilities that can be separated from other users. Once used, isolate the facility and arrange for it to be cleaned.</li> <li>• <b>Travel home:</b> individuals with symptoms should avoid the use of public transport where possible. For example, if possible a relative or other person in their household should collect them from work in a private vehicle.</li> <li>• <b>Test for Covid-19:</b> instruct the individual to arrange for a free Covid-19 test to be undertaken as soon as possible.
